Voluntary Life Coverage Election

If you (the employee) are age 65 or older: The guaranteed amount available to you and your spouse without answering health questions (Guarantee Issue Amount) and the life insurance benefit amount elected are subject to benefit reductions due to your age. At age 65, the guaranteed amount and the benefit elected decrease by 35% of the original amount. At age 70, amounts decrease by 60%. At age 75, amounts decrease by 75%. At age 80, amounts decrease by 85%. As your life insurance benefit amount decreases, your premium amount will also decrease. If applicable, reduced benefit amounts may be shown below.

I understand that if coverage is applied for in the future, it must be during an enrollment period or due to a life change event as defined by the policy, and that a waiting period may apply.
